National framework for FI-US research cooperation

- Political governmental commitment to raise R&D spending up to 4% of GDP by 2030
- USA is regarded as a priority in terms of promoting international R&D collaboration
- RCF's Finnish Research Flagships as platforms for collaboration
- Increased investments and new funding opportunities are on the horizon and some of them already in the pipeline



Research Council of Finland / Basics



- Long-term aim to strongly increase and support research collaboration between Finland and the U.S.
- Already long-term promotion of research funding cooperation with the NSF and NIH.
- Support in the form of funding for joint FI-US projects. Joint efforts with the NSF and the NIH follow a Lead Agency model.
- Recent new opportunities for cooperation: U.S.
 Department of Defense, NASA

RCF collaboration with NSF and NIH



- National Institutes of Health
- Collaborative research activities falling within the missions of participating **NIH Institutes and Centers** and the thematic areas of **Finnish Research Flagships**, e.g., *Artificial Intelligence (AI); Digital Precision Cancer Medicine; Gene, Cell and Nano Therapy; Immune System; Inequalities, Interventions and New Welfare State.*
- Collaborative research activities in areas at the intersection of core research programmes in the NSF Directorate for Computer and Information Science and Engineering (CISE) and the thematic areas of Finnish Research Flagships, i.e., Artificial Intelligence (AI) and Wireless Communication Technologies.







State-level agreements

- Agreements between Finland and several U.S. states and areas have been / are being established
- Agreements in place with <u>Colorado</u> and <u>Texas</u>
- Special funding for international collaboration in HPC 2023:
 - Collaboration in high-performance computing with Colorado, Texas, Japan, EU – EuroHPC, LUMI
 - Another call in 2024 is foreseeable...



Possible future funding opportunities

- Joint projects linked to developing and/or utilizing highperformance computing resources
- Joint projects targeting new high risk research areas linked to the thematic areas of the RCF Flagships
- New multidisciplinary topics and fields of cooperation with our U.S. partners (cf. JCM priorities: 6G/NextG, Quantum technologies, Biotechnology/materials/economy, Climate issues, Space etc.)
- Promotion of researcher mobility / student mobility
